POINT NO.1

- Question paper is prepared in conformity with the Competency Based Assessment Module for Under Graduate Medical Education 2019 by Medical Council of India (Presently National Medical Commission) – Annexure 2 and students may be trained accordingly.
- To continue with the existing system of conducting MCQs in the last half an hour of University theory examinations for the time being.
- Approved the modifications in the existing scheme of practical examination for Anatomy, Physiology and Biochemistry and to implement the modified practical scheme from the academic year 2020-2021 admission onwards.

- No separate Histology and Gross Anatomy records, as the components are incorporated in the Under Graduate Assessment Record of Anatomy.

POINT NO.2

- The Institution shall maintain the attendance for Foundation course and to ensure that the candidates fulfil the GMER 2019 before appearing for University examinations.
- To continue the existing system of conducting/ eight Internal Assessment Tests in each subject and to take the average marks of the eight tests.
- To conduct one Internal Assessment Test in Community Medicine during the first year MBBS as per Competency Based Assessment Module 2019 – Annexure I. The marks may be included in the Internal Assessment of Community Medicine in Third Professional Part -I.
