The following recommendations of the Standing Academic Board was approved by the Governing Council at the 282nd meeting held on 19.07.2021. The Standing Academic Board has resolved that

POINT NO.1

To follow the Competency Based Curriculum of Second MBBS pertaining to Syllabus, Teaching hours, Formative Assessment, Summative Assessment, Eligibility criteria for appearing for Examination, Pattern of Question paper in the University examination, Conduct of examinations and Pass criteria as prescribed under Part II of the Regulations on Graduate Medical Education,1997 by Medical Council of India (Presently National Medical Commission Regulations).

To conduct eight Internal Assessment in all subjects and average of eight assessment test will be taken as final marks.

Further resolved that

- (1) Candidates should observe 15 Autopsies in clinical postings during Phase II & III MBBS.
- (2) External and Internal Examiners be present physically during Practical Examinations and to adhere to Advisory issued by the National Medical Commission in this regard.
- (3) University shall collect a copy of all Internal Assessment question papers including MCQs in Word Format from the affiliated institutions to add to the Question Bank in the University.
- (4) To approve the Practical Scheme for Pathology, Microbiology and Pharmacology and the portions pertaining to Paper I and Paper II of each subject.
- (5) To preferably have an ACME trained faculties as Moderators of question papers.

POINT NO.2

Uniform pattern of logbook be prepared and to circulated to the affiliated institutions by the University Further resolved that the Logbook and Academic Record should contain all the activities carried out by the student along with Learning Objectives and to include the repeat/remedial activity of the student in the Assessment Record.
