The recommendations of the Board of Studies in Final MBBS degree was approved by the 60th Meeting of Standing Academic Board held on 29.04.2021 and passed in the 282nd meeting of the Governing Council held on 19.07.2021, which are detailed below:

Regarding on the implementation of Competency Based Curriculum of Under Graduate Degree course for Final MBBS Part I and II, published by the Medical Council of India (National Medical Commission) New Delhi,

the Board has resolved

(i) to implement the Competency Based Undergraduate Curriculum for the Indian Medical Graduate of Under Graduate for Final MBBS Part I and II, as per the guidelines of Medical Council of India (Presently National Medical Commission).

(i) to have a student Logbook which includes Academic and Assessment components. The concerned Departments shall also maintain the assessment summary of the students.

(ii) to approve the recommendations of Board of Studies that Medical Education Unit in Medical Colleges shall organize continuous sensitisation programme for their faculty in Curriculum Implementation Support Programme (CISP) and Competency Based Medical Education.
