I am to inform you that, the minutes of the meeting of the Board of Studies in PG Allied Health Science Degree courses held on 01.08.2023 was recommended by the Standing Academic Board, at the 62nd meeting held on 17.08.2023. The following recommendations of the Standing Academic Board was approved by the Governing Council at the 297th meeting held on 28.08.2023.

RESOLUTION NO. 1:

The Standing Academic Board has resolved that henceforth the Regulations of Break of Study and readmission for all courses of study shall be as follows:

1. Each Candidate shall complete the duration of the Course as prescribed by the respective Councils/Regulatory Bodies.
2. The mandated percentage of attendance and maximum duration to complete the course as per the respective Councils / Regulatory Bodies norms should be complied with. Where there are no Councils, the University norms will prevail.
3. A candidate should obtain Condonation Order from the University, if he/she is absent / continuously on leave for more than three months along with the payment of the requisite fee. The respective institutions should forward the request of the student within two week's time. If delayed, it must be sent with the requisite penal fee.

This rule shall come into effect on approval by the Governing Council. The existing rules will cease to exist henceforth.

RESOLUTION NO. 2:

The Standing Academic Board has resolved to follow the regulations and Scheme of Examinations for Post Graduate Diploma in Auditory Verbal Therapy course as per RCI norms for the Academic Year 2022-2023.

RESOLUTION NO. 3:

The Standing Academic Board has resolved to approve the change of Academic Year from (October to September) to (June to May) for Post Graduate Diploma in Public Health Journalism Course conducted by the Department of Epidemiology of this University.

RESOLUTION NO. 4:

The Standing Academic Board has resolved to change the Nomenclature of the course of PG Diploma in Public Health Journalism as PG DIPLOMA IN MEDICAL JOURNALISM course.

RESOLUTION NO. 5:

The Standing Academic Board has resolved to implement recommendation of Rehabilitation Council of India regarding change of Examination Pattern from Semester to Annual Pattern with effect from Academic Year 2023-2024 for all University affiliated courses recognized by Rehabilitation Council of India.

In continuation to the above, RCI has issued circular No.7-91/Policy/2019/RCI, dated 25.04.2023 that the instructions issued on 27.03.2023 regarding change of semester pattern to Annual Pattern stands cancelled.
