Resolved to approve the minutes of the 62<sup>nd</sup> Meeting of the Standing Academic Board held on 17.08.2023

**MINUTES OF 62<sup>ND</sup> MEETING OF THE STANDING ACADEMIC BOARD 17.08.2023 – THURSDAY at 11.00 a.m.**

The Vice-Chancellor welcomed all the members to the 62<sup>nd</sup> Meeting of the Standing Academic Board.

During discussion, the Vice Chancellor has informed to revamp the existing Regulations of Break of Study and readmission for all courses.

Henceforth the Regulations of Break of Study and readmission for all courses of study shall be as follows:

1. Each Candidate shall complete the duration of the Course as prescribed by the respective Councils/ Regulatory Bodies.
2. The mandated percentage of attendance and maximum duration to complete the course as per the respective Councils/ Regulatory Bodies norms should be complied with. Where there are no Councils, the University norms will prevail.
3. A candidate should obtain Condonation Order from the University, if he/she is absent / continuously on leave for more than three months along with the payment of the requisite fee. The respective institutions should forward the request of the student within two week's time. If delayed, it must be sent with the requisite penal fee.

This rule shall come into effect on approval by the Governing Council. The existing rules will cease to exist henceforth.

The Vice-Chancellor has also suggested that :

- 1 The convenor of the examination be directed to submit the details of OSPE / OSCE along with check list to the Controller of examinations of this University after completion of each examination.
2. In order to speed up the result process, Institutional Heads must take the responsibility to provide a common evaluation centre with internet facility and CCTV in their respective Institutions, so that the paper valuation could be done in their respective Institutions itself and it can also be monitored from the University.
3. All Institutions are requested to send the sixth monthly attendance particulars of students of all courses to the University.

Regarding registrations of students in the first year of study:

1. The Institutions must forward the list of students admitted in their Institutions within two weeks time from the cut of date of admission.
2. The University shall open the CMS Portal for the registration of the students the day next to the cut off date for admission. The Institutions are instructed to enter all the details of the students for purpose of registration within four weeks of the cut of date of admission.
3. Spot verification needs to be done within one month, so that ineligible candidate's list can be communicated to the Institutions and Selection Committee for further course of action before completion of two months from the cut off date of admission.

Further informed that

It has been proposed to create Multi Disciplinary Research Unit in each medical college so that undergraduate students can learn about research while pursuing the undergraduate course itself. It has been decided that all the undergraduate students must be posted compulsorily in the Research Department of the Institutions.

It has been proposed to earmark 26<sup>th</sup> September every year as Research Day which will be celebrated at the University level.

1. Each Candidate shall complete the duration of the Course as prescribed by the respective Councils/ Regulatory Bodies.
2. The mandated percentage of attendance and maximum duration to complete the course as per the respective Councils/ Regulatory Bodies norms should be complied with. Where there are no Councils, the University norms will prevail.
3. A candidate should obtain Condonation Order from the University, if he/she is absent / continuously on leave for more than three months along with the payment of the requisite fee. The respective institutions should forward the request of the student within two week's time. If delayed, it must be sent with the requisite penal fee.

This rule shall come into effect on approval by the Governing Council. The existing rules will cease to exist henceforth.
