**Regulations for the Degree of Doctor of Science (D.Sc.) – 2010.**

**1. PREAMBLE**

The Degree of Doctor of Science (D.Sc.) is the highest degree of this University.

In exercise of the powers conferred by section 44 of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, Act, 1987 (Tamil Nadu Act 37 of 1987), the Standing Academic Board of the Tamil Nadu Dr. M.G.R. Medical University, Chennai, hereby makes the following regulations:

**2. SHORT TITLE AND COMMENCEMENT:**

These regulations shall be called “THE REGULATIONS FOR THE DEGREE OF DOCTOR OF SCIENCE (D.Sc.) – 2010 OF THE TAMIL NADU Dr. M.G.R. MEDICAL UNIVERSITY, CHENNAI’.

These regulations are applicable for the D.Sc. candidates who are registered from 1<sup>st</sup> July 2010 onwards.

The regulations framed is subject to modification from time to time by the Standing Academic Board of the University.

**3. ELIGIBILITY**

3.1. A candidate who has qualified for the Degree of Doctor of Philosophy of this University or from any other University in any one of the faculties approved by the Governing council and who has subsequently carried out Post-Doctoral Research work for a period of one year in the Departments of this University or in colleges affiliated to this University or in a Medical Council of India approved research institution located anywhere in India recognized for the research leading to the award of Ph.D. Degree may present themselves for the degree of Doctor of Science (D.Sc.).

3.2. Such candidate who is full time teacher/research scholar in the departments of this University/affiliated colleges or in a Medical Council of India approved institution is only eligible to submit their thesis for the award of degree of Doctor of Science (D.Sc.)

**\*\*3.2a The D.Sc research study shall be done at any of the recognized departments of the Institutions affiliated to this University.**

3.3 \* In the faculty of Medicine, Dentistry, Indian Medicine & Homoeopathy and Allied Health Sciences should have completed ONE YEAR of research experience after Ph.D.

3.4. \* Candidates should have published minimum of TEN Research Papers related to the speciality but different from the publications during Ph.D.

3.5. \* Atleast in 50% of the publications, the candidate should be the First Author.

3.6. \* Publications should be in Indexed Peer Reviewed Journal with decent Impact Factor and sufficient citations.

#### 4. ELIGIBILITY CERTIFICATE FOR D.Sc. CANDIDATES

The candidates applying for D.Sc. Provisional Registration in this University for January/July Session should obtain Eligibility Certificate from the University. For JANUARY SESSION the candidate has to get Eligibility Certificate between 16<sup>TH</sup> OCTOBER to 15<sup>th</sup> NOVEMBER and for JULY SESSION between 16<sup>TH</sup> APRIL to 15<sup>th</sup> MAY.

## **5.. PROCEDURE FOR REGISTRATION**

5.1. A candidate for the award of Doctor of Science (D.Sc.) shall apply with the University by remitting the prescribed fees along with the application form as in Annexure - I obtained from the University for Registration, duly filled in within the stipulated periods for the month of January and July . The application form may also be downloaded from the University Website [www.tnmmu.ac.in](http://www.tnmmu.ac.in). The cost of the application is Rs. 5,000/- or the amount prescribed by the University from time to time. If downloaded, the cost of application has to be paid along with other fees

### **5.2. Registration session**

Registration for D.Sc. degree shall be done twice during the year (i.e.) January and July. At the time of Registration, the candidate should give the names of 12 experts in the chosen field with full contact details.

5.3 The candidate has to submit the abstract of the thesis in a detailed manner along with the duly filled in application form and fees to this University. The abstract of the thesis will be scrutinized by the D.Sc. Advisory Committee and also name a panel of suitable examiners to evaluate the thesis. The committee shall consist of experts in the speciality concerned and allied professionals in the field of research.

**5.4. IF THE D.Sc. ADVISORY COMMITTEE REJECTS THE ABSTRACT OF THE THESIS ON TWO SUCCESSIVE OCCASIONS, THEN THE CANDIDATE HAS TO SUBMIT A FRESH APPLICATION ALONG WITH THE PAYMENT OF STIPULATED FEES AS MENTIONED IN THE REGULATIONS.**

5.5. The candidate once chosen the topic of the D.Sc. thesis can be changed partially and not completely. The partial modification of the thesis can be allowed only before the end of the first year of the research work . If the candidate has changed the title of thesis completely during the period of research study, the candidate will be discharged from the D.Sc. programme immediately.

5.6. During the five year period of the research work, the candidate has to publish atleast three research publications as the principal author to his credit in any indexed / accredited journal.

5.7. If the candidate has not submitted the three research journals during the five year period of the research work, the thesis submitted by the candidate will not be sent for evaluation.

5.8. The total duration of D.Sc. is five years from the date of Registration of the candidate.

5.9. If the candidate fails to submit the thesis at the end of the fifth year, the candidate will be discharged from the D.Sc. Programme

## **6. SUBJECT OF THESIS**

6.1. The thesis submitted by the candidate for consideration for the award of the degree of Doctor of Science (D.Sc.) shall be substantially the result of post-doctoral research work done in the University Departments / any affiliated Colleges or in any Medical Council of India approved research institutions located anywhere in India.

6.2. The subject will be a reflection of the work done in one year after Ph.D. The candidate shall state in their Registration application the special subject on which the candidate bases their qualification for the D.Sc. Such subject shall be one which relates to the main / related theme of knowledge chosen for the Ph.D. Degree. If the thesis submitted has formed in part the basis for the award of a previous research Degree, the candidate shall clearly set forth in the preface or in a written statement the portion or portions upon which the award of the previous degree was based. The candidate shall submit their application with six copies of the abstract of the D.Sc. thesis which shall be in the form of published work, or published paper(s) or books, that contain original contribution to the advancement of knowledge. The candidate shall also not enclose the publications which contain the materials on which they obtained the Ph.D. Degree. The initiation chapter of the thesis may summarise the doctoral work of the candidate supported by publications and thus indicate the theme of the D.Sc. thesis. The candidates should also provide a detailed citation index of their publications wherever applicable. The D.Sc. thesis must be on a series of connected papers alone on the main theme and additional papers can be submitted in support of the main theme only on the understanding that the candidate indicates to that effect in the preface of the thesis.

6.3. The thesis must be on one main theme and it should not be a series of unconnected papers.

6.4. The candidates in their preface and notes shall indicate the sources from which the information had been obtained and in what respect the investigations carried out by them lead to advancement of scientific Medical knowledge and form a valuable contribution to the field of Medical Science in the subject.

6.5. The change of subject should be clearly set forth in the preface while submitting the D.Sc. Thesis.

## **7. SUBMISSION OF THESIS**

7.1. The candidate shall submit the thesis three months before at the end of fifth year which should be a distinct contribution to Medical Scientific knowledge. Each set consist of:

a) Six typed copy of the thesis

b) Six copies are to lbe submitted as an electronic version of the entire thesis in a standard CD format, Mention must be made about the CD formatting and technicalities used in the CD making and presentation.

7.2. The application and the thesis must be forwarded with the prescribed fee so as to reach the Academic Officer on any working day during the year The fee prescribed shall be remitted through online PAYMENT GATEWAY, Indian Overseas Bank or the IOB challan to be paid at The Tamil Nadu Dr. M.G.R Medical University Premises. No demand Draft /Banker's Cheque will be accepted for the above amount.

The fees prescribed above are subject to modification by the University from time to time.

**8. DECLARATION**

The thesis shall include a declaration signed by the candidate that it has been composed by them independently and has not previously formed the basis for the award of any Degree, Diploma, Associateship or Fellowship or other similar title in any other University. If the thesis submitted is partly the basis for the award of a previous research degree, the candidate shall clearly set forth in the preface by written statement the portion or portions which have formed the basis for the award of the previous degree.

**9. CERTIFICATION**

The head of the Departments and head of institution / affiliated colleges / approved institutions should certify that the candidate carried out the work of Post-doctoral research independently and is a full-time Faculty Member / Research Scholar in the Department / Institution. The certificate shall be included in the thesis.

**10. ADDITIONAL PAPERS**

The candidate may with the thesis shall enclose printed copies of any original contribution or contributions to the knowledge of their subject or of any cognate subject which might have been published by them independently or co-jointly as evidence of their interest in the field of research.

**11. D.SC. ADVISORY COMMITTEE AND EXAMINERS.**

11.1 The University shall form a D.Sc., Advisory Committee consisting of 3 members approved by the Vice-Chancellor for every candidate who is submitting the abstract of the thesis. The committee shall consist of experts in the speciality concerned, research workers and allied professionals in the field of research for which the D.Sc. thesis is submitted.

11.2. The D.Sc. Advisory Committee shall three examiners from the list of twelve names suggested by the candidate.

11.3. If the panel of twelve names of external examiners suggested by the D.Sc. Advisory Committee is found to be inadequate the Vice-Chancellor shall have the power to appoint additional examiners in consultation with the experts of his choice in the concerned field.



## **12. EVALUATION OF THE THESIS**

12.1 The thesis shall be referred by the Vice-Chancellor for evaluation to a Board of Examiners consisting of three persons one from Southern State, one from Northern India and one from abroad from the panel submitted by the D.Sc. Advisory Committee. The evaluation report shall be as in annexure II.

12.2. The D.Sc. thesis submitted by the candidates shall be sent to three Examiners one abroad and one from Southern State and one from North India.

12.3. The Board of Examiners who value the thesis shall report on the merit of the candidate for the award of D.Sc. Degree.

12.4. Each examiner will be given three months time to submit the evaluation report. A reminder will be issued for submission of the evaluation report.

12.5. If no response is received within 3 (three) months then the university will automatically send the copies of the thesis available to the next examiner from the same section to be selected by the Vice-Chancellor with similar instructions.

12.6. Total of 3 (three) approved reports are absolutely essential.

12.7. The three approvals may be obtained at the first or subsequent resubmission of the thesis as the case may be.

12.8. The approved reports by initial set of examiners will be taken into consideration at all stages in deciding the final result.

## **13. RE-SUBMISSION / REJECTION OF THESIS.**

13.1 The Thesis with some shortcomings pointed out by the Examiners will be returned to the candidates for rectification of the defects. Such candidate may resubmit the thesis with all corrections and suggestions implemented in the resubmitted thesis.

13.2. A candidate whose Thesis has not been approved in the first instance may be permitted to re-submit the thesis with corrections and modifications for the second time after a period of 6 (six) months and within 2 (two) years with further publications on the subject. The re-submitted thesis will be evaluated by same examiners chosen from the original panel.

13.3. A candidate shall ordinarily be permitted to re-submit a thesis for the award of D.Sc. degree for not more than two occasions within the maximum period of 2 years.

13.4. If two examiners have given negative reports then the thesis is deemed as rejected.

#### **14. DECLARATION OF RESULTS.**

The evaluation reports of the Board of Examiners shall be placed before the Governing Council for approval and declaration of the result of the candidate for the award of the Degree of Doctor of Science (D.Sc.).

#### **15. ISSUE OF PROVISIONAL / DEGREE CERTIFICATE.**

A candidate who has been successfully declared to have qualified for the Degree of the D.Sc. shall be issued D.Sc. provisional /Degree Certificate duly mentioning the branch / field of /Research / Specialization under which the candidate has carried out his D.Sc. research work.
