3.	Receipt of Compliance Reports/Replies from the applicant Institutions	1 st October to 31 st October
4.	Scrutiny of Compliance Reports & Perusal	Till 15 th February
5.	Notification of Rejection of any application	15 th February
6.	Issue of Letter of Consent of Affiliation to Eligible Institutions	28 th February

* To start the course in the academic year 2022-2023, the filled in applications and appropriate valid enclosures should reach the University between 1st June 2020 and 31st July 2020.

MDS Degree Course

- 1) Starting of new course - FORM - A / increase of seats - FORM- E (Application for Letter of Consent of Affiliation).
- 2) Evidence to show that the College / Institution / Hospital has been in existence.
- 3) The first batch of students of BDS degree course has passed out from the existence Institution.
- 4) In addition to the land, area and other conditions prescribed for B.D.S. degree Course, for existing Colleges shall have a ready-built area of 1000 sq.ft., for each speciality including laboratory facilities.
- 5) Category wise Teaching Staff details.

6) Fee details:-

- i) Application fees for starting of New / Increase of seats: Rs.14,160/- (Rs.12,000/-+ GST18% Rs. 2,160),
- ii) Letter of Consent of Affiliation Processing Fees of Rs.70,800/- (60,000/- + GST18% Rs.10,800).
- iii) Inspection Fee of Rs.59,000/-(50,000/- + GST18% 9,000)

7) Fees amount shall be remitted through RTGS / NEFT online remittance system and submit the proof of remittance along with the details 1), 2), 3).4) and 5)

NOTE:

- Only the Education Trust / Societies / Organization as defined in the Dental Council of India Regulation shall be eligible to apply for the Letter of Consent of Affiliation.
- Application from individuals for the Letter of Consent of Affiliation shall not be entertained.
- **Belated submission of application for obtaining Letter of Consent of Affiliation for starting of new course / increasing of seats will not be considered. Piecemeal Application and application received after the Last date will be summarily rejected.**
