I am to inform that the Meeting of the Board of Studies in Homoeopathy Course was held on 18.12.2015 and discussed various academic matter. The decisions of the Board of Studies in Homoeopathy Course was approved in the 51st meeting of the Standing Academic Board, held on 21.01.2016 and recorded in Resolution No.32 in the 243rd Meeting of the Governing Council held on 03.03.2016 which are detailed below:

1) TO START e' CONSORTIUM AND e' JOURNALS FOR EXTENDING THE FACILITY TO THE HOMOEOPATHY DEGREE COURSE.

Resolved that the books and journals related to the Homoeopathic Medicine be added to the Library e-consortium subject to the availability of e-books for extending the facility to the Homoeopathy discipline also.

2) As per Homoeopathy (degree course) Amendments Regulations, 2015 of BHMS degree course:

“There shall be a regular examination and a supplementary examination in a year and the supplementary examination shall be conducted within two months of declaration of results (including issue of mark sheets.)”

It was resolved to approve the Homoeopathy (degree course) Amendments Regulations, 2015 of BHMS degree course. In this regard, a clarification on the following issues have been already sought from Central Council of Homoeopathy vide letter dt.21.9.2015.

1. Carry over of Pharmacy to Second year
2. Supplementary Exams
3. Migration for transfer

Resolved to implement the Homoeopathy (Degree Course) Amendments Regulations, 2015 for students admitted in I year B.H.M.S. degree course from the academic session 2015-16 onwards.

Further, it was resolved to conduct the supplementary examinations for I year B.H.M.S. after the publication of results as per the Homoeopathy (Degree course) Amendments Regulation, 2015 for the students admitted from the academic session 2015-16 onwards.

In continuation to this University Letter dated:21.09.2015, the clarification received from Central Council of Homoeopathy, New Delhi, was communicated to all Homoeopathy Medical Colleges, vide University's letter dated: 19.02.2016 with an instruction to follow the said norms strictly without any deviation.

3) THE IMPLEMENTATION OF GUIDELINES GIVEN IN THE JUDGEMENT BY HONOURABLE HIGH COURT IN W.P. NO.35108 OF 2014 – K. REGARDING APPOINTMENT OF SCRIBE IN THE UNIVERSITY EXAMINATION.

Resolved to implement the following guidelines of Honorable High Court Order No.W.P.(c) No.35108 of 2014 (K) dated 25.2.2015 along with the other guidelines prescribed in the office memorandum F.No.16-110/2003-DD.III dated 26th February 2013 of Government of India, Ministry of Social Justice and Empowerment, Department of Disability Affairs:

The facility of Scribe/ Reader/Lab Assistant should be allowed to any candidate who has a disability of 40% or more if so desired by the candidate.

The word “extra time or additional time” that is being currently used should be changed to “compensatory time” and the same should not be less than 20 minutes per hour of examination for persons who are making use of scribe/reader/lab assistant. All the candidates with disability not availing the facility of scribe may be allowed additional time of minimum of one hour for examination of 3 hours duration which could further be increased on case to case basis”.

I am to request that the decision of the Standing Academic Board as mentioned above may be communicated to all the Professors and Heads of Departments for information and further follow up action in the regard. I am also to request that a copy of this letter may be displayed on the Notice Board of the College / Hostel for information of the students concerned.
