I am to inform that the Meeting of the Board of Studies in Unani Course was held on 06.04.2017 and discussed various academic matters. The decisions of the Board of Studies in Unani Course was resolved by the 53rd meeting of the Standing Academic Board, held on 27.04.2017 and passed in the 253rd Meeting of the Governing Council held on 29.06.2017 which are detailed below:

1. DECIDE ABOUT THE U.G REGULATION PRESCRIBED BY THE CENTRAL COUNCIL OF INDIAN MEDICINE, NEW DELHI TO BE IMPLEMENTED FROM 7TH NOVEMBER 2016 BASED ON THE GAZETTE NOTIFICATION FOR BUMS DEGREE COURSE

It was **resolved** to follow the UG Regulation prescribed by the Central Council of Indian Medicine, New Delhi for BUMS Degree course as per the Gazette Notification from 7th November 2016. The extended cut-off date for the academic year 2016-2017 was 31st December 2016 and this regulation has been implemented for the candidates admitted for the academic year 2016-2017.

2.THE COPY OF THE LETTERS F.No.R-13040/33/2016-HD(Tech) Part DATED 08-11-2016 REGARDING ADMISSIONS IN INDIAN MEDICINE COURSES IN THE COUNTRY THROUGH NATIONAL ELIGIBILITY CUM ENTRANCE TEST (NEET) ONLY FROM THE SESSION 2017-18 FROM THE ASSTT.SECRETARY (TECH.) CENTRAL COUNCIL OF HOMOEOPATHY, NEW DELHI Lr.No.:14-6/2016-CCH (Pt)/22982-23241 DATED:18.11.2016.

As per the communication from Ministry of AYUSH F.No.R-13040/33/2016-HD (tech) Part dt 26.04.2017, the admission in AYUSH UG courses shall be compulsorily through NEET merit list from the academic year 2018-19 and hence this will be implemented for the UG candidates admitted from the academic year 2018-19.

3.DECIDE ON THE MINIMUM EXPERIENCE REQUIRED FOR THE FACULTIES OF U.G. DEGREE COURSE IN UNANI TO APPOINT THEM AS PAPER VALUATOR, MODERATOR, ORAL/PRACTICAL EXAMINER AND QUESTION PAPER SETTER.

It was **resolved** to follow the CCIM norms for the Examiner. The same experience criteria may be considered uniformly for Paper valuator, Moderator, Oral/Practical Examiner and question paper setter for the University examinations for UG course. Further, it was also resolved to conduct the Oral/Practical Examinations for 25 candidates per day.

I am to request that the decision of the Standing Academic Board as mentioned above may be communicated to all the Professors and Heads of Departments for information and further follow up action in the regard. I am also to request that a copy of this letter may be displayed on the Notice Board of the College / Hostel for information of the students concerned.
