Science Courses for the academic year 2011-2012 –

I am to state that as per Regulations of various under graduate
degree courses of this University (i.e) Medical/ Dental / Indian
Medicine and Homoeopathy and Allied Health Science Courses, the
Cut - off date for admission to 1st year course for the academic year
2011-2012 was fixed upto 30th September 2011.

The University has decided to grant grace period for this academic
year 2011-12 up to 14th October 2011 for the receipt of Eligibility
Certificate application from the candidates those who are applying after
the cut - off date (i.e. 30.09.2011) for admission to all under graduate
degree course. The reason for the grant of grace period is some of the
candidates will join the course in your institution on the last day of the
cut off date (i.e) 30.09.2011 without getting Eligibility Certificate and
some of the Eligibility Certificate applications already submitted by the
candidates have not been accepted at the reception counter of this
university due to insufficient documents. The candidates those who are
applying for Eligibility Certificate during the period of grace time from
3rd October 2011 to 14th October 2011 has to remit a sum of Rs.1500/-

(Rupees One Thousand Five Hundred Only) towards fee for belated submission of Eligibility certificate application..

Therefore, I am to request you to direct the candidates of your Institution those who have already joined the course, and not get the Eligibility Certificate from this University may be requested to apply and get the Eligibility Certificate from this University on or before 30th September 2011, failing which the candidate has to remit a sum of Rs.1500/- towards fee for belated submission of Eligibility Certificate application and Eligibility fee of the concerned courses. The belated submission of Eligibility Certificate application will also be entertained by this University from 3rd October 2011 to 14th October 2011 only.

The University is also issuing conditional Eligibility Certificate for the candidates those who are applying for Eligibility Certificate without producing Migration certificate or Nursing council Registration Certificate. In the conditional Eligibility Certificate it has been clearly mentioned the date of submission of required documents along with other original documents for the issue of Eligibility Certificate. But in some cases, the candidate will submit the required documents with other original documents to this University, after two or three months from the prescribed date for the issue of Eligibility Certificate.

The candidates those who are submitting the required documents after the prescribed date mentioned in the conditional Eligibility Certificate, the candidate has again to remit the fresh Eligibility Certificate fee of the concerned courses. The remittance of fresh Eligibility certificate fee will come into effect from 20th September 2011 onwards.
