I am to inform that the Meeting of the Board of Studies in Ayurveda Degree Course was held on 21.11.2013 discussed various academic matters. The decisions of the Board of Studies in Ayurveda Degree Course was approved in the 47th Meeting of the Standing Academic Board, held on 18.12.2013 and passed in the 225th Meeting of the Governing Council held on 07.01.2014 which are detailed below:

1. TO FOLLOW THE U.G. SYLLABUS OF SECOND YEAR AYURVEDACHARYA (B.A.M.S.) COURSE FRAMED BY THE CENTRAL COUNCIL OF INDIAN MEDICINE, NEW DELHI.

The Standing Academic Board has resolved to follow the Syllabus and Regulations of the Central Council of Indian Medicine for Second year Ayurvedacharya (B.A.M.S) Degree Course.

2. THE REQUEST OF THE CHAIRMAN, DHARMA MEDICAL RESEARCH AND CHARITABLE TRUST, CHENNAI TO START THE FOUR YEAR COURSE OF B.PHARM – AYURVEDA AND APPROVE THE SYLLABUS AND REGULAIONS OF THE SAID COURSE.

The Standing Academic Board has approved the starting of the course B.Pharm – Ayurveda. This new course will enable students to learn all the Pharmacological aspects of Ayurveda thereby opening new frontiers and job opportunities in all Hospitals and manufacturing units of Ayurveda. An expert committee may be formulated to frame the Syllabus and Regulations for the course.

3. THE IMPLEMENTING BREAK SYSTEM EVERY YEAR FOR THE BAMS DEGREE COURSE.

It was resolved to follow the norms of the Central Council of Indian Medicine.

Any other items:

1. Resolved that from February 2014 / April 2014 session onwards, only single valuation will be done for all Undergraduate.
2. Resolved that, "once hall ticket is issued by the University to a candidate based on his/her application for Examination submitted along with necessary fee forwarded by the College, it will be treated as an attempt irrespective of the fact whether the candidate is actually appearing for the Examination or not due to any reason." Only when the candidate has taken up / appeared for any part of the Examination, it will be considered as an appearance.
3. The fees for issue of Migration certificate need to be collected along with the Examination fees and the Migration certificate shall be issued on receipt of the application.

I am to request that the decision of the Standing Academic Board as mentioned above may be communicated to all the Professors and Heads of Departments for information and further follow up action in the regard. I am also to request that a copy of this letter may be displayed on the Notice Board of the College / Hostel for information of the students concerned.
