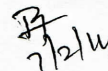
1. Resolved to form a Committee in regard to starting of Postgraduate course in M.D. Naturopathy and Yogic Sciences in view of framing Rules, Regulations and Syllabus.
2. It was resolved that from February 2014 / April 2014 session onwards, only single valuation will be done for all Undergraduate.
3. It has been resolved that, "once hall ticket is issued by the University to a candidate based on his/her application for Examination submitted along with necessary fee forwarded by the College, it will be treated as an attempt irrespective of the fact whether the candidate is actually appearing for the Examination or not due to any reason." Only when the candidate has taken up/appeared for any part of the Examination, it will be considered as an appearance.
4. The fees for issue of Migration certificate need to be collected along with the Examination fees and the Migration certificate shall be issued on receipt of the application.

I am to request that the decision of the Standing Academic Board as mentioned above may be communicated to all the Professors and Heads of Departments for information and further follow up action in the regard. I am also to request that a copy of this letter may be displayed on the Notice Board of the College / Hostel for information of the students concerned.
